The 17th Annual **Beaver County Law Enforcement Invitational**, hosted by the Beaver Valley Combat Association, will be held on September 11, 2010. Matches will start promptly at 8:00 am at the Beaver Valley Rifle & Pistol Club, Route 51, Chippewa Township, just West of the entrance to Brady's Run Park. The event is open to all law enforcement agencies and individuals as well as their guests. The event will consist of the following matches; Singles Match (Law Enforcement & Civilian), Two-Man Team Match and Four-Man Team Match. The Entry Fee for participation is \$30.00 per entrant. This fee entitles participants to shoot in any or all matches. The field will be limited to sixty (60) participants on a first come first serve basis. Shortly after the entry deadline, all participants will receive a Match Schedule, which will state your match times. **Note:** If you would like to request a specific match time please indicate your choice on the entry form and the best effort will be made to accommodate your request. Matches will run at 30 minute intervals, i.e., 8:00am, 8:30am, etc., to accommodate the number of participants.

The Match course of fire is as follows:

Stage 1: 12 rounds in 25 seconds from the 7-yard line.

Stage 2: 18 rounds in 90 seconds from the 25-yard line in the following positions, 6 rounds kneeling, 6 rounds left handed, left hand side of the barricade, and 6 rounds right handed, right hand side of the barricade.

SCORE AND CHANGE TARGET

Stage 3: 24 rounds in 2 min. 45 seconds from the 50-yard line in the following positions; 6 rounds sitting, 6 rounds prone, 6 rounds left handed, left hand side of the barricade, and 6 rounds right handed, right hand side of the barricade.

Stage 4: 6 rounds in 12 seconds from the 25-yard line, point shoulder, unsupported.

SCORE TARGET - END OF MATCH

(Scoring: 600 total points, using the scoring rings on the B-27 target, X, 10 = 10; 9 = 9; 8 = 8; 7 = 7; outside 7 ring = 0)

Awards will be presented based upon the number of entrants per event, and is preliminarily set at Gold, Silver & Bronze medals for each match and for three shooting classifications per match. In addition to the awards numerous door prizes will be distributed. At the conclusion of the scheduled matches, the awards ceremony will be preceded by a Grilled Steak Dinner with the customary side dishes and a variety of beverages.

Weapons may not have a barrel length in excess of six inches (6"), must be a service/duty weapon, (factory issue, open sight), and should be chambered for .38 cal. or larger. Each match will require 60 rounds of ammunition. Other required equipment will be speed loaders or

Weapons may not have a barrel length in excess of six inches (6"), must be a service/duty weapon, (factory issue, open sight), and should be chambered for .38 cal. or larger. Each match will require 60 rounds of ammunition. Other required equipment will be speed loaders or spare magazines (a minimum of 4), a strong side holster (cross draw, shoulder rigs, IWB, ankle holsters, etc. are not permitted for safety reasons), and all participants must use eye and hearing protection. **All participants will be required to sign and date the Waiver of Liability Statement on the entry form.**
